The incumbent will be responsible for execution of all the activities being carried out by PSEB, and plan new initiatives.

Qualification & Experience:

- Degree in Computer Science/ IT/ Electrical/ Electronic Engineering or Marketing/ Management/ Business Administration (minimum 16 years of education from HEC recognized University). Preference will be given to candidates having a bachelors degree in a technical field and a Masters degree in Marketing/Management/Business Administration.

Age Limit: Maximum 55 years of age by the closing date of applications.

Required Skills-Set /Job Description
